



The Community of Three Rivers Snowshoe Rental Agreement

Terms of Agreement:

1. Snowshoes will be picked up and dropped off at the Municipal Office located at 63 Main Street Petitcodiac. Rental equipment may be picked up by users and transported to other locations within The Community of Three Rivers. We do not deliver or pick up equipment. Office hours are Monday to Friday 8:30 am – 4:30 pm.
2. Snowshoes will be returned in the same condition in which they were received. Renter is responsible for any and all damage incurred beyond normal wear and tear. Renter must provide valid credit card in order to book snowshoes. In the event a snowshoe is damaged, lost or stolen, the credit card will be charged for a replacement set of the same or most similar snowshoes.
3. For those wishing to rent again during one season, it is understood that this agreement will be kept on file along with credit card information for the duration of the snowshoeing season.
4. Waiver of Participant by Parent or Self: I hereby agree to release, discharge, and hold harmless The Community of Three Rivers (COTR), its directors, officers, employees, agents, contractors, and/or volunteers from any and all liability or obligation that may occur during use or the use of the COTR's snowshoes and poles. This includes any injury or damage to the person or property of others, which causes or contributes to while using the snowshoes, poles, or any other equipment rented from the COTR. I understand that participation in any recreational or sport activity involves risk, and I further understand that The Community of Three Rivers does not provide insurance for participants.

I AM 19 YEARS OF AGE OR OLDER, AND I HAVE READ AND UNDERSTAND THIS AGREEMENT. I UNDERSTAND THAT THIS DOCUMENT CONTAINS A PROMISE NOT TO SUE THE COMMUNITY OF THREE RIVERS, THEIR DIRECTORS, OFFICERS, REPRESENTATIVES, MUNICIPAL COUNCIL AND EMPLOYEES AND THAT IT CONSTITUTES A RELEASE OF LIABILITY AND INDEMNITY FOR ALL CLAIMS.
